A director of forensics/speech and debate coach:

1. Is a member of the school's faculty, staff, or a district-approved designee of the designated school. This designee must have fingerprints on file with the State of California and your district, and need to have appropriate clearance to be working with students.
2. Is responsible for receiving and sending SDIVSL communication for the school.
3. Is responsible for the safety of students from the school at SDIVSL activities.
4. Accompanies students to all SDIVSL activities, arrives on time, and is in attendance for the entire duration of the activity. If it is impossible for a coach to go with students, another qualified adult (see Rule #1) shall accompany students and be responsible for adhering to all rules and regulations at SDIVSL activities. A qualified adult may substitute for a coach only if he or she presents a letter of authorization from the administration of the school represented.
5. Represents the school at SDIVSL Coaches' meetings.
6. Is responsible for arranging payment of fees, dues and obligations owed to the SDIVSL for the school's participation. School/district check, personal check, money order, or cash may pay any fees due to SDIVSL.
7. Submits team entries, scripts, signatures, and necessary paperwork for all tournaments within designated timelines.
8. Checks in at each tournament with the director and provides assistance in the tab room or performs other duties as assigned by the tournament director.
9. Works with team to provide at least the minimum number of judges required for each tournament (according to the tournament invitation).
10. Sees to it that students dress and behave in accordance with rules and bylaws of the SDIVSL.
11. Helps students choose appropriate material for a speaking event.
12. Maintains a professional demeanor in SDIVSL activities.
13. Judges only if requested by the SDIVSL tournament director. Cannot be designated as a judge to meet a school's judging requirements, unless approved by the Executive Council prior to the tournament.

Fee information:

- Dues for participation in the SDIVSL are \$60.00 annually. These dues may be waived for first-year teams. If you believe your school qualifies for a waiver, please contact the SDIVSL president.

- Each school is responsible for entry fees for each tournament in which they have students competing. Entry fees are \$6.00 per student, per event, for each tournament.

As the Principal of _____ High School, I have read and understand the above information regarding designation of a Director of Forensics/Speech & Debate Coach for the San Diego Imperial Valley Speech League. I understand that the requirements, allowances and conditions of other leagues may differ from those of the SDIVSL and do not necessarily meet SDIVSL terms of participation. Any violations of the above stated criteria may result in disqualification from SDIVSL tournaments. The SDIVSL Constitution and Bylaws are supplemental documents, which include coaching and team requisites.
